- To prepare Quarterly/Annual Financial Statement/Reports to be placed before the iii. Management.
- To Prepare of the details, Verify the accuracy of TDS deduction and returns filed in prescribed iv. forms with relevant tax authorities.

- The CA/CMA Firms should be in Practice for a period of 3 years or more.
- Have at least 1 (one) fulltime ACA/ FCA/ACMA/FCMA partners/ employees who are associated with the firm for more than 1 (one) years, out of which 1 (one) partner should be stationed at Bhagalpur.

Terms & Conditions:

- The firm must have a branch office in Bhagalpur and all communication to the firm will be made to that office address only.
- 2. The selection of the firm will solely rest on the discretion of the Authority.
- Quotation received after the due date and time will not be considered.
- 4. The firm quoted the lowest price for the work as mentioned in ToR shall be selected for giving the services at BSCL.
