Clause No. 33.1	Within 15 (Fifteen) days of receipt of the Letter of Acceptance, the successful Bidder shall deliver to the Employer a Performance security in any of the forms given in 32.2 for an amount equivalent to 3% of the Contract price. Including earnest money plus additional security for unbalanced Bids in accordance with the Clause 29.5 of ITB and the provisions of Bihar Financial Rules.	Within 15 (Fifteen) days of receipt of the Letter of Acceptance, the successful Bidder shall deliver to the Employer a Performance security in any of the forms given in 33.2 for an amount equivalent to 2% of the Contract price and provision to take an additional security for unbalanced Bids in accordance with the Additional Performance Guarantee of RFP.
65 / Clause No. 7.5.1	From every payment for Works due to the Contractor in accordance with the provisions of Clause-17.5, the Authority shall deduct 8% (eight percent) thereof as Guarantee money for performance of the obligations of the Contractor during the Construction Period (the "Retention Money") subject to the condition that the maximum amount of Retention Money shall not exceed 10% (ten percent) of the Contract Price.	The person/persons whose tender(s) may be accepted (hereinafter called the contractor) shall permit Authority at the time of making any payment to him for work done under the contract to deduct a sum at 8% (eight percent) from the gross amount of each running bill till full amount of security deposit 10% (ten percent) of agreement value or value of work (whichever is higher) is reached. If value of work exceeds the agreement value, security deposit (10%) will be recovered for the exceeded work.
